- OOA breeders must purchase UNIT TEN bands, no outside banded birds can participate in this race.
- OOA Extra Prizes: 1st - 300 pts, 2nd -200 pts, 3rd - 100 pts
- OOA birds become the property of the handler, unless other private arrangements are made.
- Local lofts must buy 5 bands to handle OOA birds.
- OOA birds may be shipped SAL LAMA, 17820 MONTEVERDE DR., SPRING HILL, FL 34610
- To participate, OOA breeders can purchase bands by sending a check payable to "UNIT TEN PIGEON CLUB," c/o SAL LAMA, 17820 MONTEVERDE DR., SPRING HILL, FL 34610

2008 ACTIVATED BANDS RULES

A SECOND SET OF 'FREE' UNIT TEN BANDS WILL BE GIVEN TO ALL BUYERS OF UNIT TEN BANDS, INCLUDING OUT-OF-AREA BUYERS. LOCAL FLYERS MUST BUY 10 BANDS TO RECEIVE 10 FREE BANDS. ANY "FREE" UNIT TEN BAND MAY BE ACTIVATED BY PAYING \$25 PER BAND ON SHIPPING NIGHT. OUT-OF-AREA BUYERS MUST ACTIVATE 2 WEEKS BEFORE SHIPPING NIGHT. ANY UNACTIVATED OOA BIRDS MAY BE PURCHASED AT NIGHT OF SHIPPING BY THE FLYING MEMBER.
